What is Point-in-Time (PIT)?

- ▶ **A snapshot** of people experiencing homelessness on a given night
- ▶ Count of people in **HUD homeless category 1**
 - Sheltered count: emergency shelters and transitional housing
 - Unsheltered count: streets, cars, tents, etc.
- ▶ Coordinated by HSC Point-in-Time Committee
- ▶ 4th Wednesday in January and July



Other Ways to Understand the Extent of Homelessness

- ▶ Coordinated Entry Housing Priority List
 - ▶ Annual Homeless Assessment Report (AHAR)
 - ▶ Number of Homeless Students –School Districts

2019 July PIT

- ▶ On the night of July 24, 2019
- ▶ Mild weather: high 85, low 60, around 70 degrees during the unsheltered count
- ▶ 11 teams/44 volunteers on the PIT night
- ▶ Post count by 5 additional volunteers at The Beacon, Bethel, Safe Haven, and remote camp sites



2019 July PIT Summary Findings

650 total persons experiencing homelessness
(category 1 literally homeless)

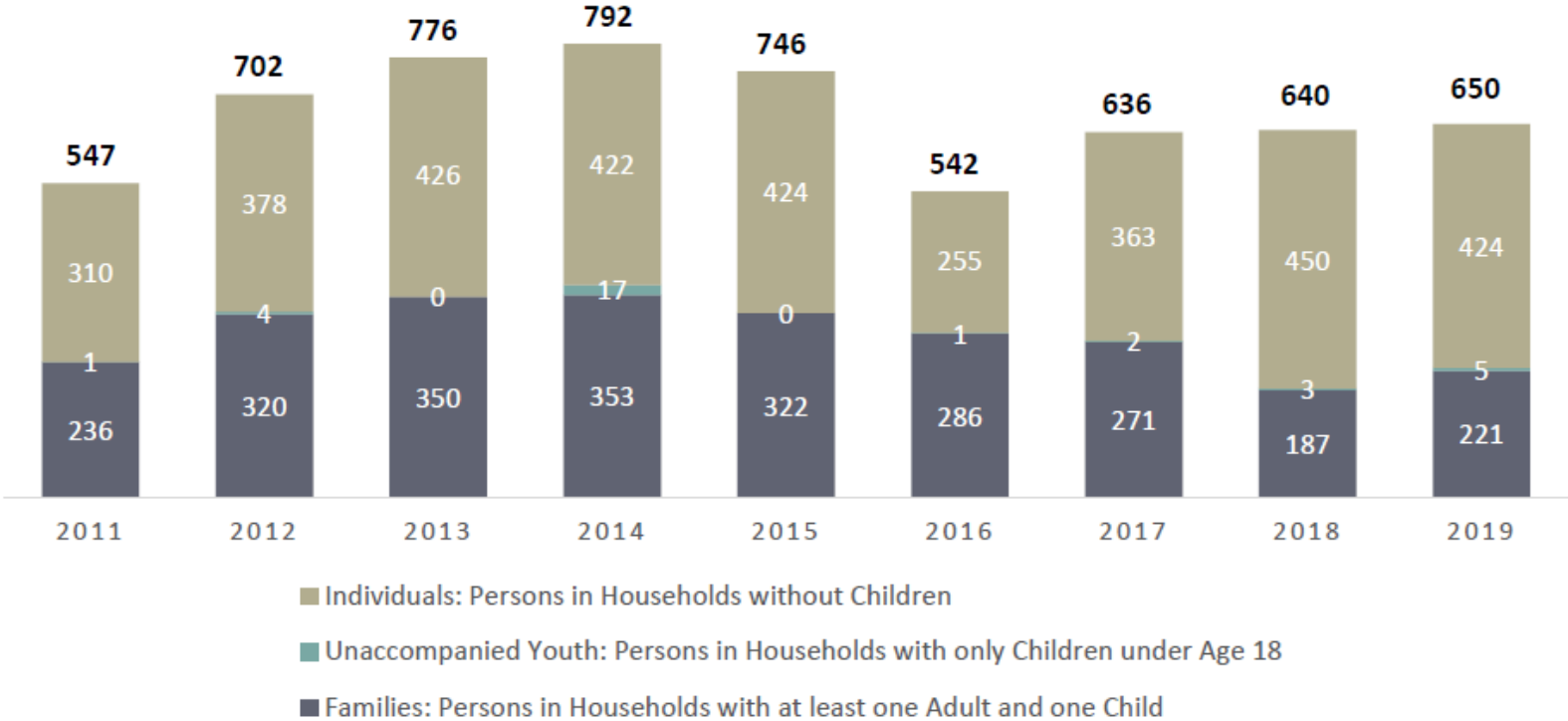
221 persons (60 families) in households with children

424 persons in households without children

5 unaccompanied youth age under 18

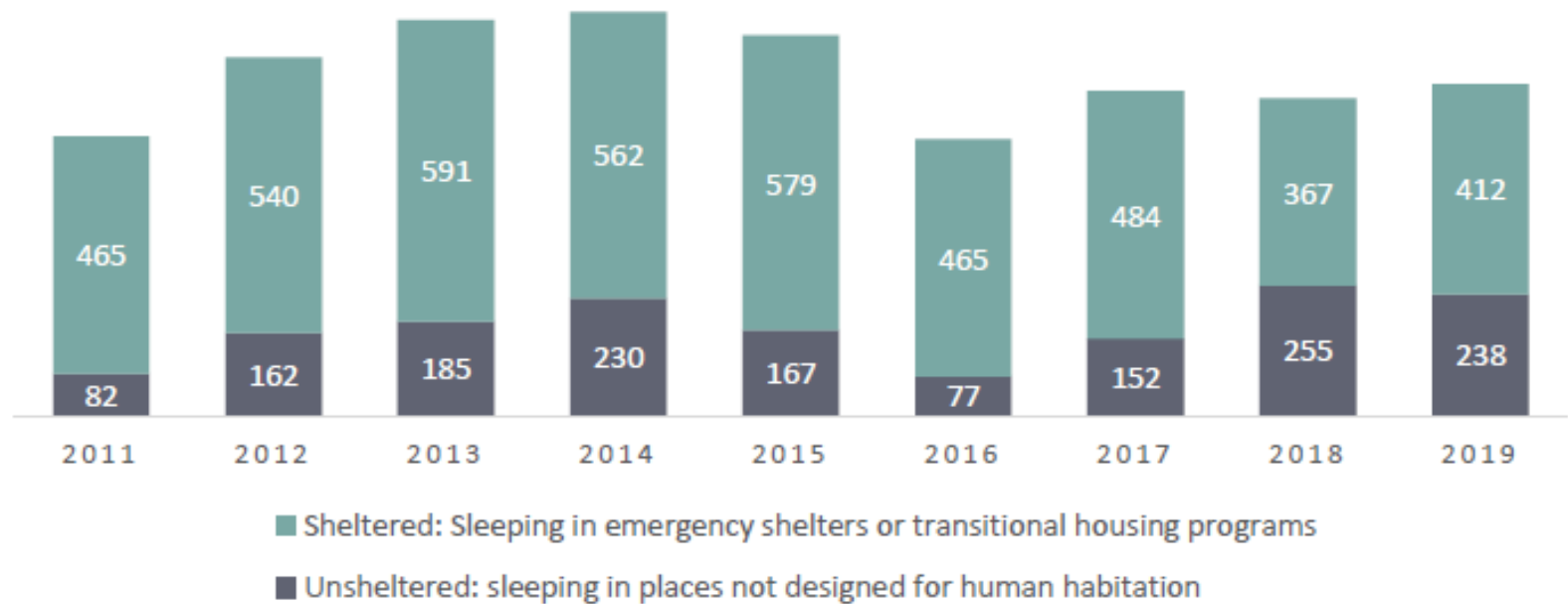

BY HOUSEHOLD TYPE

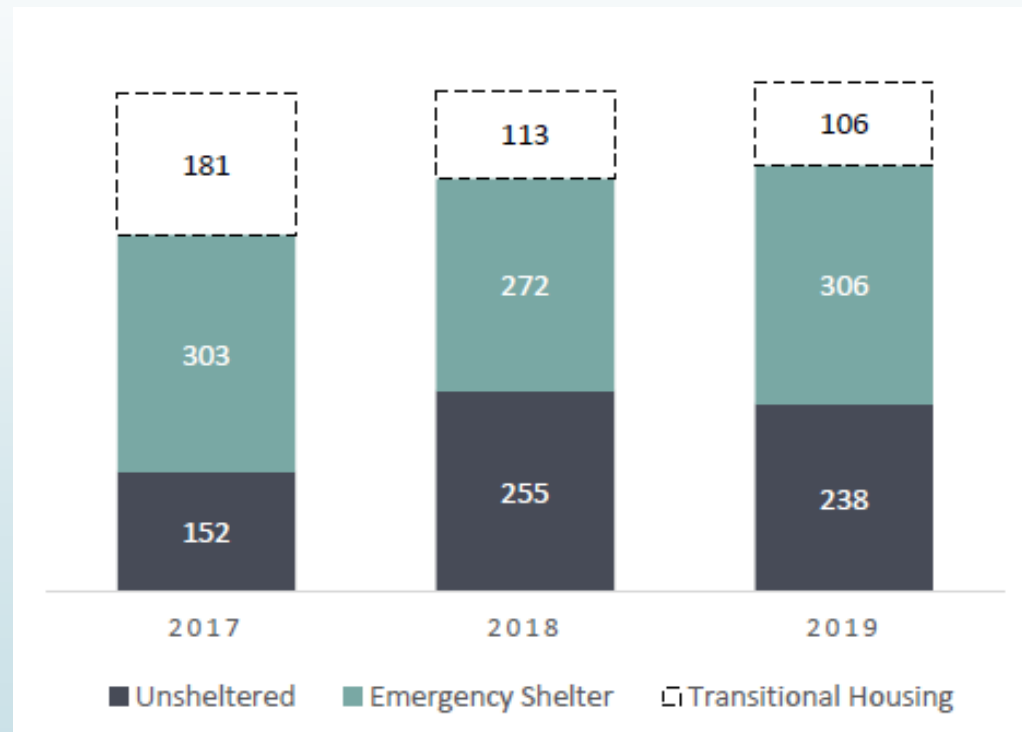


July PIT: 2011-2019

BY SLEEPING LOCATION

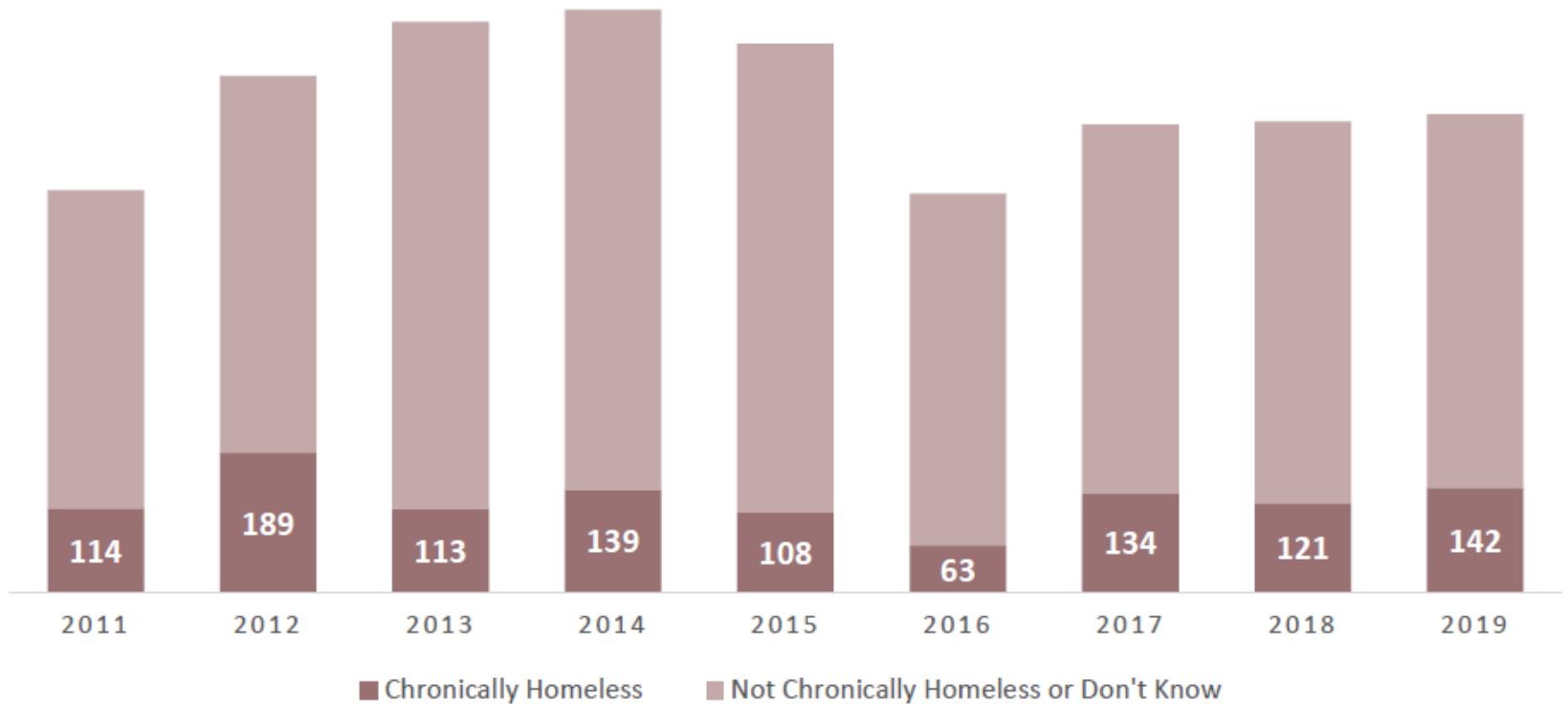


July PIT: 2017-2019 ES and Unsheltered Only



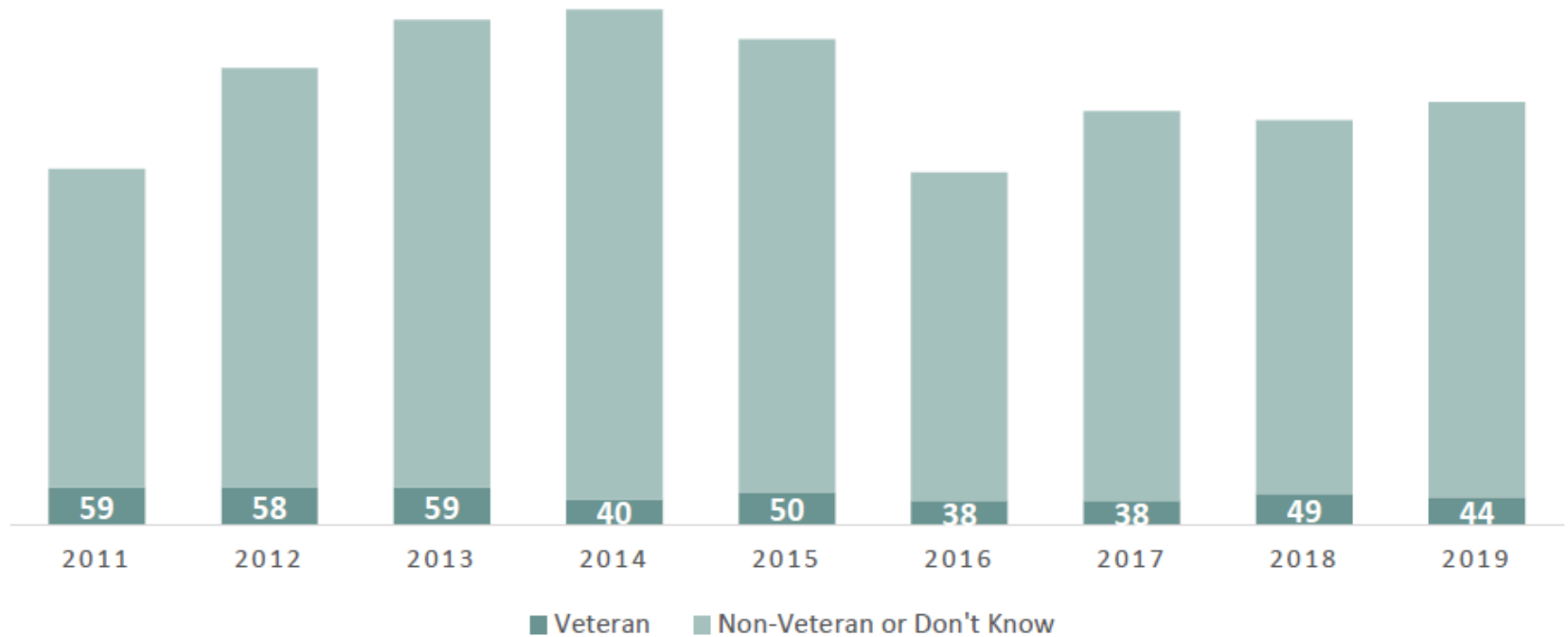

CHRONICALLY HOMELESS



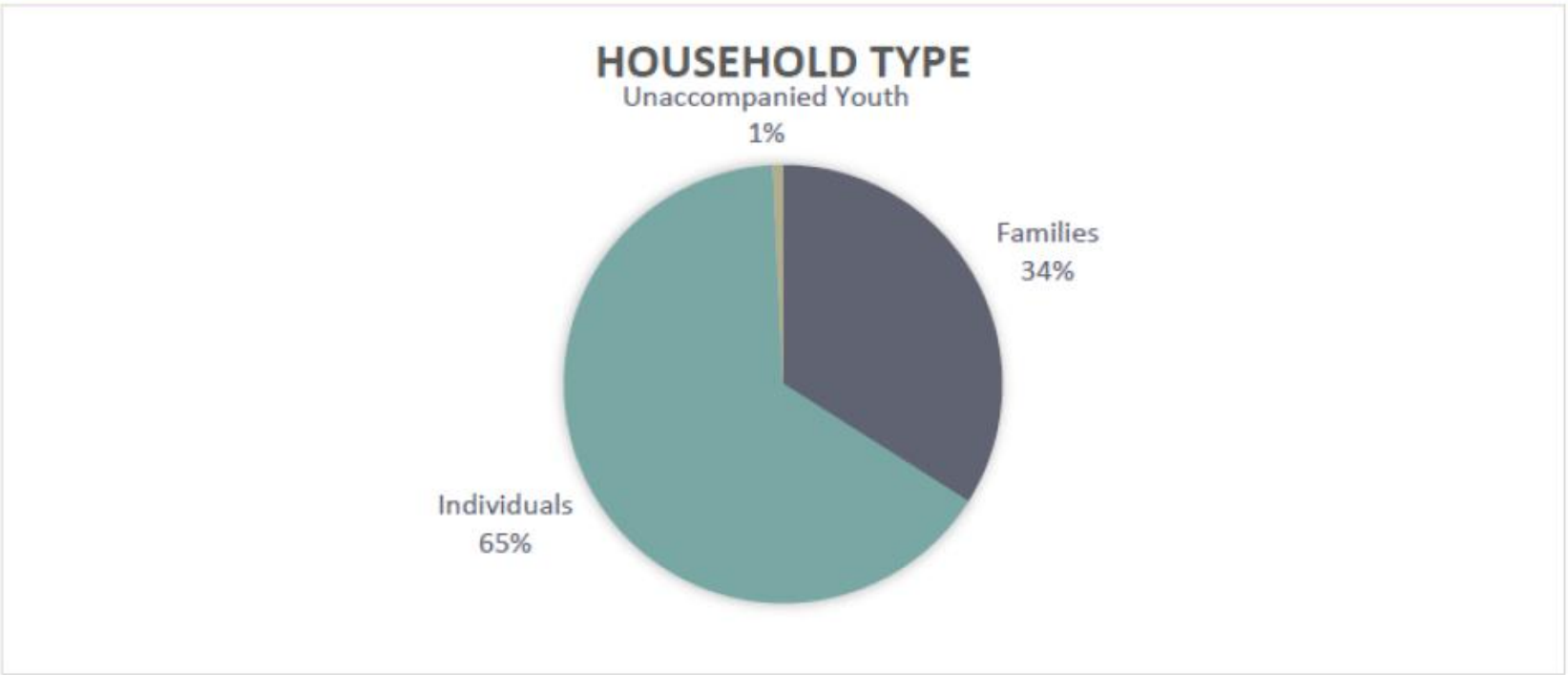

VETERAN HOMELESS



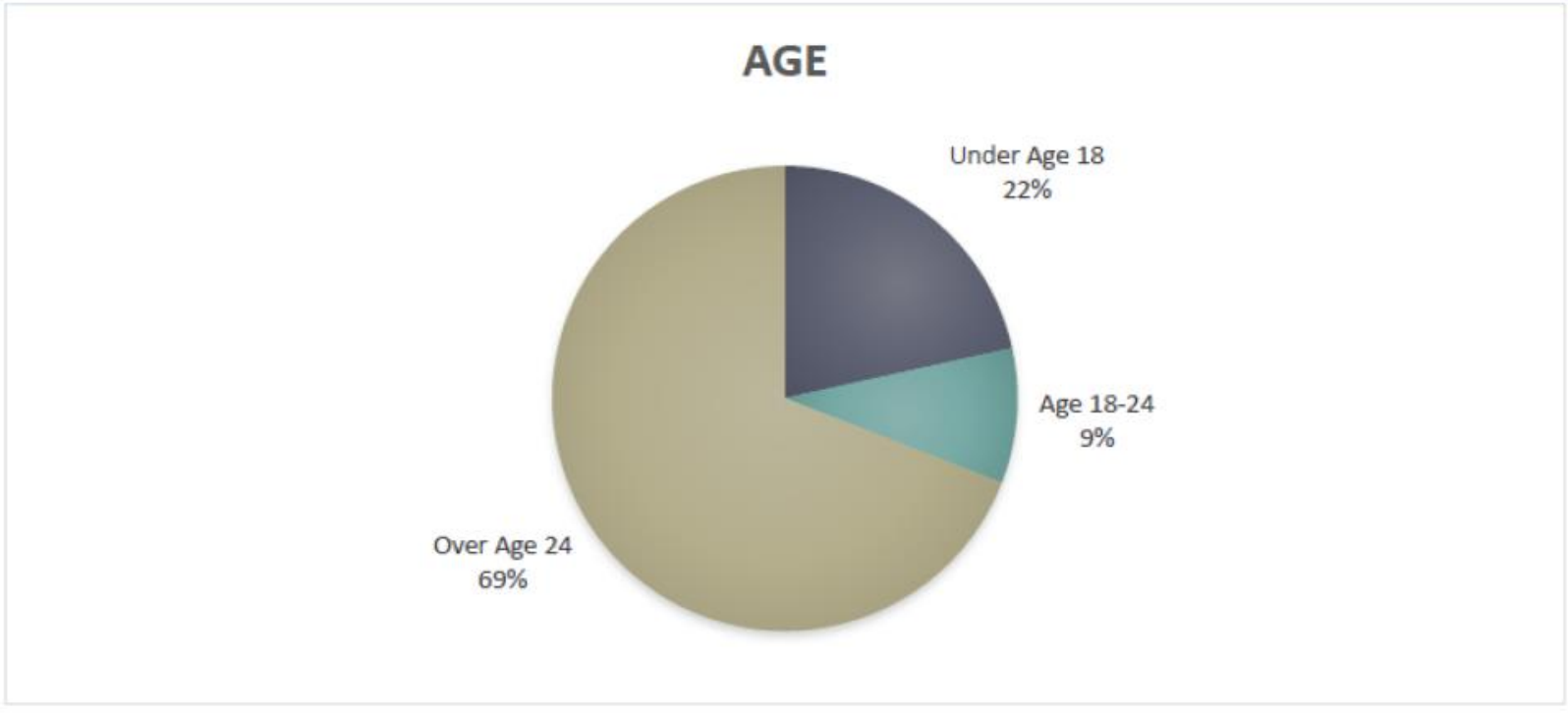

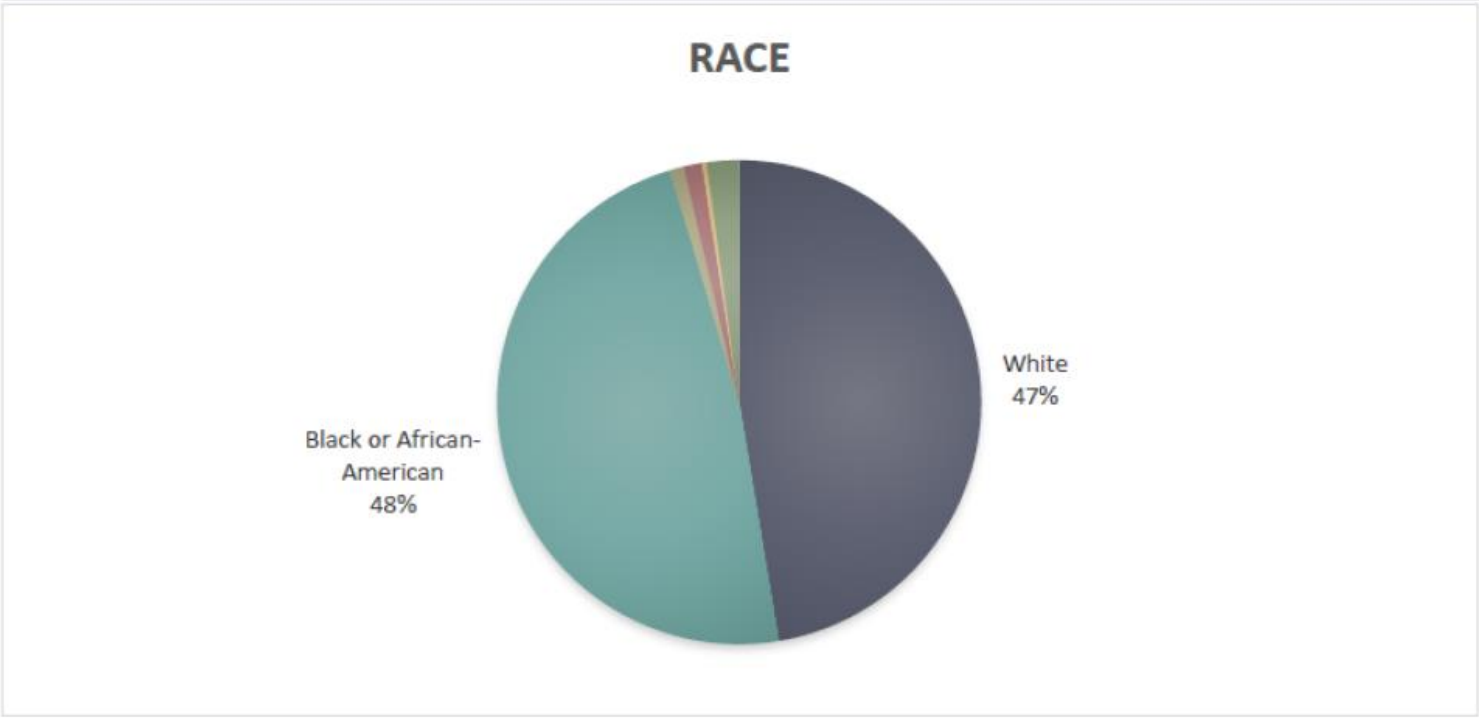

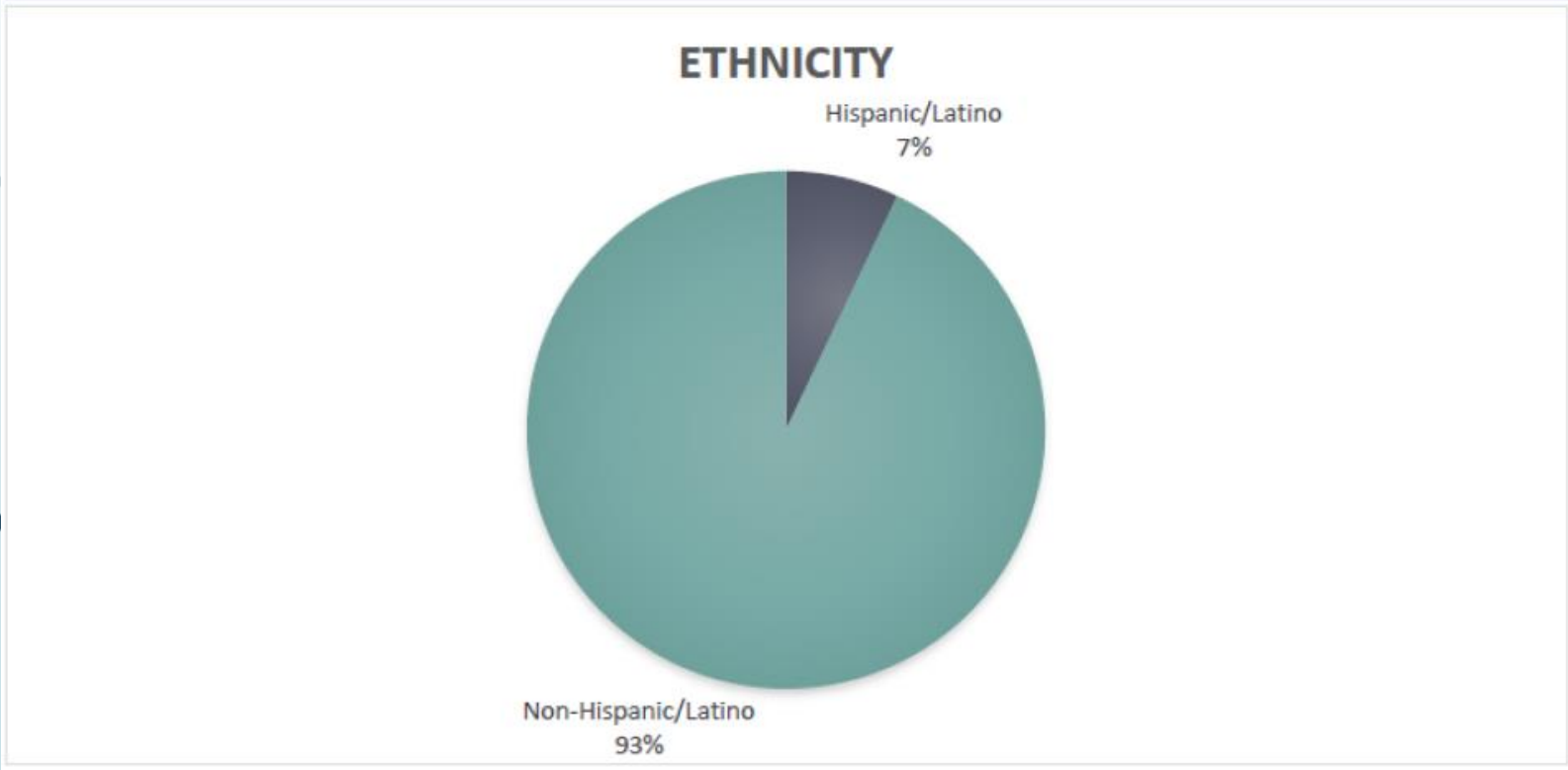

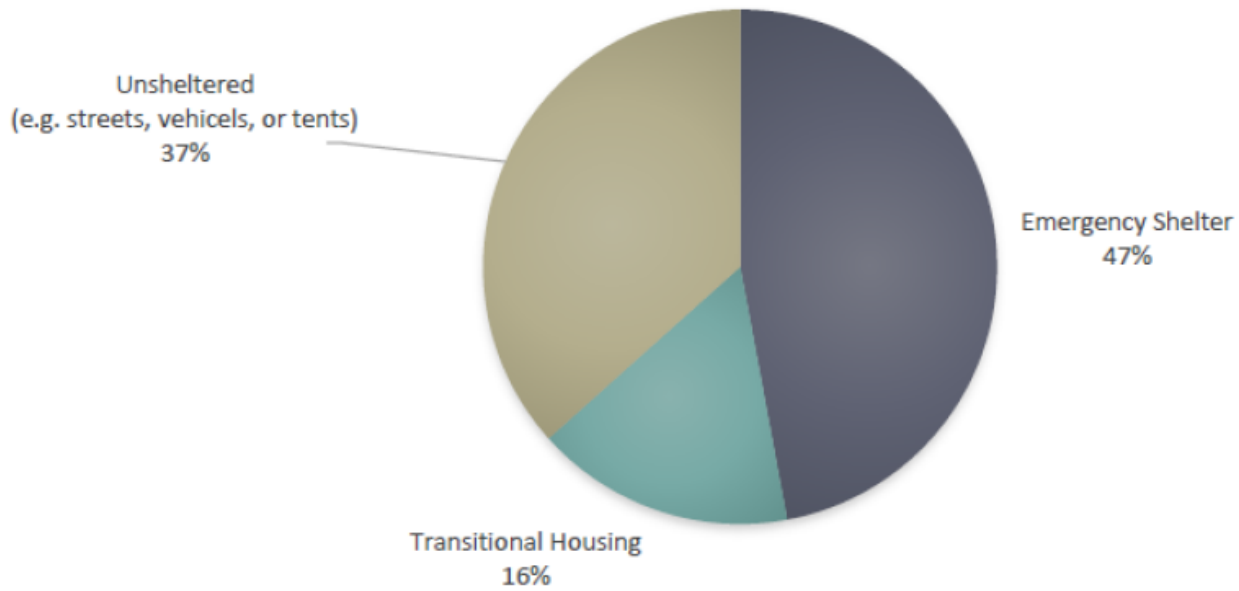

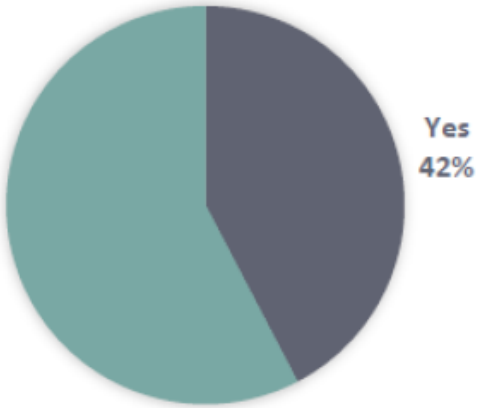
SLEEPING LOCATION



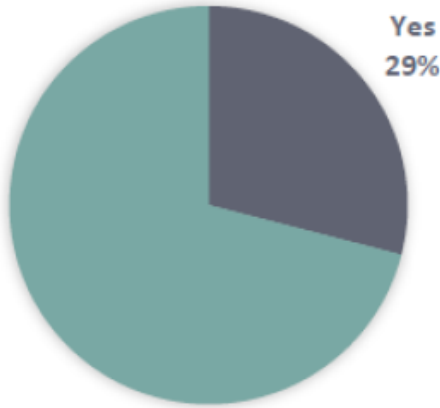

Lack of affordable housing is the main reason for homelessness.

- Fair Market Rent for a two-bedroom apartment is **\$1,093**.
- A single parent working full time at \$12/hour has to pay **53%** of the family's gross income for rent. Having to pay higher than 30% of your income for housing is considered not affordable.
- With the **3%** rental vacancy rate, families with less than perfect rental histories are often denied housing.



Racial disparity is another big factor.

African Americans make up **6%** of the general population in Dane County;

they represent **48%** of the homeless population.
